We are pleased to provide a quotation for the supply of 762 new water saving toilets for the Vancouver sites. We have received special pricing for the supply of the toilets to sites within the greater Vancouver area.

The supply of the toilets includes delivery of the toilets to the various buildings in the greater Vancouver area. The supply of the new fixtures includes new Pro Flow 3.0 lpf tanks, new round bowls, new round seats, new wax rings, new floor bolts and new supply lines.

The unit price per new fixture delivered complete is \$ 215.90 plus HST. For the delivery of 762 toilets \$164,515.80 plus HST.

The price is valid for all completed deliveries until December 30, 2023.

As an option we can provide new water and energy saving shower heads and faucet aerators. Unit price for new fixed style 1.5 gpm shower heads and 1.5 kitchen faucet aerators and 1.0 gpm bath aerators is \$ 10.75 plus HST. For the delivery of 762 shower heads and 1524 faucet aerators \$ 8,191.50 plus HST.

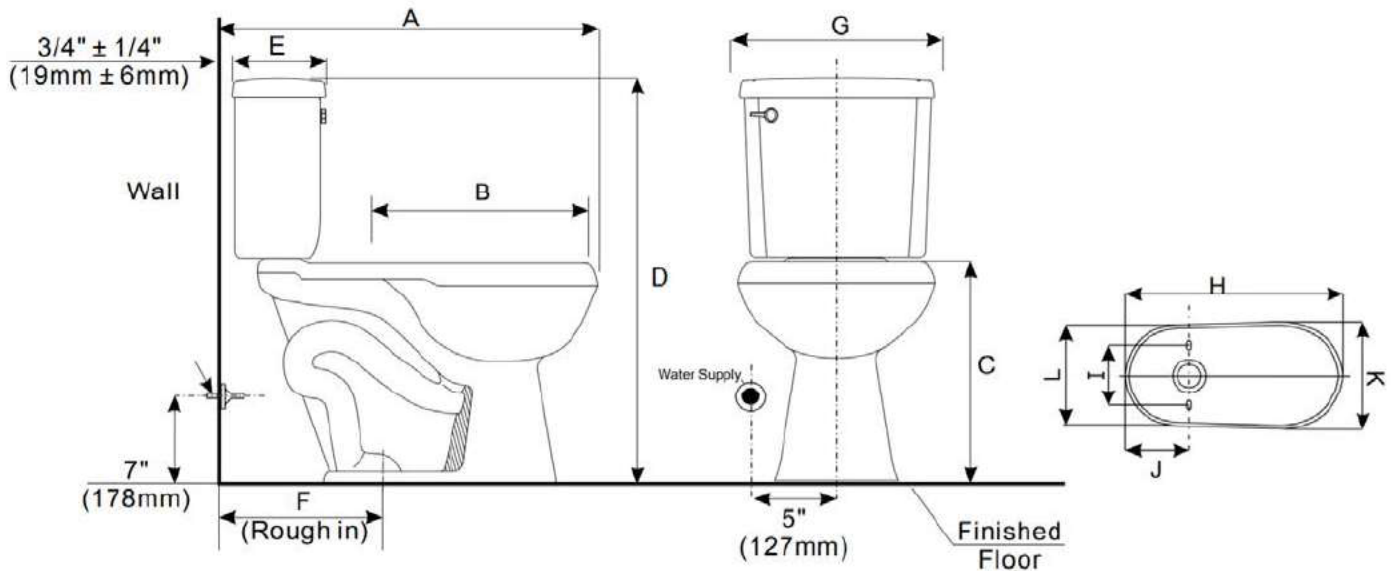

Description

Hello CAT and Hashim,

Can you please help me with the TA/BR for the BCJV Toilet Retrofit project?

We will have two vendors on this job – WCC will be supplying and APT will be installing (two separate contracts). See list below for reference, showing job number, budget allotted and units per building. As the budget per building does not necessarily make sense, we will be spreading the cost across all the buildings and using the total budget number.

Due to the nature of this project, we do not know the exact number of toilets we will need to change. We think out of 762 units, we will likely need to change out 600, give or take. So we will be using 500 as our initial total budget, but we will be phasing this. Our first phase will be all the buildings that are not located in Downtown Vancouver. (the locations that are not coloured below are the downtown locations). By my count, the initial batch will be 451 locations. Please make the first phase 500 total units.

 - Please add a separate line of \$10.75 plus HST/unit for the shower heads and faucet aerators

- Please add a 10% contingency on the entire project and phase.
