Scope of work:

Replacement of the recirculation line for Tower B on the 12th floor with shut off valves for each riser on the 12th floor in the hallway.

Scope of work:

- Supply and install a new recirculation line in Tower B on the 12th floor with shut off valves on each branch. Connect to the existing recirculation branch lines from each unit. We will attempt to connect to the existing lines before they enter the unit from the hallway. However it may be necessary in some cases to open up the ceiling inside the unit to connect to the recirculation line.
- Customer is responsible for removal of the bulkhead and drywall in the 12th floor hallway and in units.
- Includes labelling of all new recirculation isolation valves on the 12th floors.
- Access panels will need to be installed for each recirculation valve on the 12th floors. We have not included installation of access doors/panels. This can typically be performed during drywall repairs.
- Pipe insulation IS included.
- Drywall repairs are not included.
- Abatement is not included.
- After installation of the recirculation shut off valves on the 12th floor is completed, this will enable testing to be done to determine which shut off valves on the lower floor require replacement. Testing of lower floor valves is to be performed on a hourly basis extra to this quotation. Once testing is completed and the valves that require replacement are determined, a quotation for the replacement of the valves on the lower floor will be provided.
- Removal of handles (and possible complete removal of faulty valves) for the old recirculation riser shut offs located in various units on the 13th floor to be performed on an hourly basis extra to this quotation.
